

CEN No. 02/2018 – Recruitment for various posts in Level - 1**Document Verification of candidates (2nd stage)**

- 2nd stage document verification fixed from 06/04/2021 to 09/04/2021 was postponed due to the increase cases of COVID-19. Now following Standby candidates (other than PwBD) are hereby called for Document Verification (2nd stage) which will be held between 19/07/2021 to 22/07/2021.
- In order to avoid shortfall in the final panel due to absenteeism, rejection or debarment etc., candidates are being called over and above the actual number of notified vacancies.
- Candidates to note that merely calling for document verification does not confer any right on them for appointment in Railways.
- The candidature of all shortlisted candidates for Document Verification is purely provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any inconsistency/deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRBs/RRCs at any stage of the recruitment process.
- List has been arranged in the ascending order of Registration ID and not in order of merit.
- While every care has been taken in preparing the list of candidates shortlisted for Document Verification, RRBs/RRCs reserve the right to rectify any inadvertent error or typographical/printing mistakes.

Candidates are also advised to follow the following instructions :

- Candidates have to carry a negative RTPCR test report which will have to be issued from upto a maximum of 48 hours before the time of his entry into Maharashtra. Without such certificate, candidates will not be entertained for document verification as they will travel from containment zones.
- Candidates have to meet the Quarantine requirement of Maharashtra state before the due date of reporting for document verification. Candidates have to make their own arrangements. The guidelines for SOPs of Maharashtra state have also to be followed by the candidates.
- Candidates will be asked to carry/produce a COVID-19 negative certificate at the time of document verification, not more than 2 days old before leaving home. Central Railway will not be responsible to take care of the candidate fall sick at RRC/CR. In such cases, candidates have to make their own arrangements
- Use of face covers/masks is mandatory.
- Candidates must maintain a minimum distance of 6 feet at RRC/Wadibunder.
- Practice frequent hand washing with soap even when hands are not visibly dirty.
- Frequent use of alcohol-based hand sanitizers.
- Respiratory etiquettes to be strictly followed. This involves strict practice of covering one's mouth and nose while coughing/sneezing with a tissue/handkerchief/flexed elbow and disposing off used tissues properly.
- Self-monitoring of health by all and reporting any illness at the earliest to state and district helpline.
- CANDIDATES MUST HAVE DOWNLOADED AAROGYA SETU IN YOUR MOBILE AND IT SHOULD INDICATE "YOU ARE SAFE" AT THE TIME OF REPORTING.
