**RRC/CR's Notification No. RRC/CR/GDCE-02/2017 dated 01/12/2017**

**2<sup>nd</sup> Part Provisional Panel of Junior Clerk-cum-Typist under GDCE quota**

In continuation to the 1<sup>st</sup> Part Provisional Panel published on 25.01.2019, total 05 candidates (UR-04, OBC-01) have provisionally been empanelled in 2<sup>nd</sup> Part Provisional Panel on the basis of community-wise merit. The 2<sup>nd</sup> part provisional panel is attached as **Annexure-I**.

The 2<sup>nd</sup> Part Provisional panel is purely provisional and appointments of candidate as Jr. Clerk-cum-Typist will completely depend on fulfilling all other conditions like passing of requisite training wherever required, not undergoing any effective penalty, no SPE/Vig/DAR case is pending/contemplated against them, medical classification of the candidate is same or higher, fulfillment of other pre-recruitment formalities, verification of formalities etc. Appearance of one's name in the part panel does not confer any right of appointment in Indian Railway.

In terms of Railway Board's letter No. 2016/H/5/20(Policy) dated 31/01/2017, where a person has already been examined by a Medical Board in respect of his/her previous employment and if standard of Medical Examination prescribed for the medical category of the new post in the Railway is the same, then they need not be required to undergo a fresh examination.

Mere empanelment of candidates in the 2<sup>nd</sup> Part Provisional Panel does not confer upon him/her any right of appointment to the post of Jr. Clerk-cum-Typist.

While due care has been taken in preparing the panel, RRC/CR/Mumbai reserves the right to make amendments to the provisionally declared panel at any subsequent stage of selection process. Besides, if any discrepancies/malpractices are noticed or brought to the notice of RRC/CR/Mumbai, then RRC/CR reserves rights to declare any candidate unsuccessful or delete his/her name from already published panel at any stage of selection process. The decision of Chairman/RRC in this regard shall be final.
