DECLARATION OF PROVISIONAL PANEL: PART- 15

1. Provisional part panel of 02 (two) candidates for recruitment in posts in Level-1 of 7th Central Pay Commission (CPC) Pay Matrix against Centralized Employment Notice No. RRC - 01/2019 on Central Railway is attached herewith in ascending order of Roll numbers. These candidates files were previously kept pending awaiting the receipt of their Medical Fitness Certificates. Upon receipt of the certificates and having been found medically fit in the requisite category, they are now being included in this provisional part panel. This part panel is purely provisional and does not give any right to any candidate for job in Railways. If any malpractice is detected at any stage, their candidature will be terminated and the individual will be liable for criminal prosecution.
2. The Computer Based Test (CBT) was conducted from 17.08.2022 to 11.10.2022 by RRBs. A total of 7 stages of Document Verification (DV) and 3 phases of replacement DV were conducted from feb. 2023 to Nov. 2024, including supplementary DVs for absent/pending candidates. Candidates were subsequently sent for medical examination at Railway hospitals (Byculla, Kalyan, Bhusawal, Nagpur, Pune, and Solapur).
3. The part panel is prepared on the basis of overall rank in Computer Based Test (CBT) and fitness in medical category for recruitment in post in Level-1 of 7th Central Pay Commission (CPC) Pay Matrix. The seniority of the candidates selected will be decided later as per the merit position in the Panel which will be declared at a later stage.
4. Allotment of posts and divisions will be made available on RRC/CR/WB website within two days subject to merit, given options of posts, medical fitness and availability of vacancies.
5. While due care has been taken in preparing the result, RRC/Central Railway reserves the right to make amendments to the provisionally declared panel at any subsequent stage. If any discrepancies or malpractices are noticed or brought to the notice of RRC/CR at any stage, RRC/CR reserves the right to rectify any inadvertent error or Typographical/Printing mistakes and declares any candidate unsuccessful or deletes the name of candidate from the notified panel at any stage. The decision of Chairman, RRC in the matter shall be final and binding on the candidate.
6. The offer of appointment shall be sent separately by the respective unit/division where the candidates are allotted. The offer of appointment will be issued after verification as per extent rules.
