**NOTICE FOR DECLARATION OF DIVERSION PROVISIONAL PANEL OF B2/C1 MEDICALLY FIT
CANDIDATES TO WESTERN RAILWAY AND WEST CENTRAL RAILWAY**

1. In terms of Railway Board's letter No. E(NG)II/2023/RR-1/63 dated 16.12.2024 & 10.06.2025, Board have decided to divert remaining 230 B2/C1 medically fit candidates to Western Railway and West Central Railway subject to the willingness of the candidates. Accordingly, the unconditional willingness was called from the B2/C1 candidates. The following 165 B2/C1 medically fit candidates submitted their unconditional willingness for diversion. Accordingly, the diversion provisional panel of 82 B2/C1 candidates to Western Railway and 83 B2/C1 candidates to West Central Railway (Total=165) in ascending order of Roll number is issued with the approval of the Competent Authority. This panel is purely provisional and does not give any right to any candidate for job in Railways. If any malpractice is detected at any stage, their candidature will be terminated and the individual will be liable for criminal prosecution.
